##### Maximum quota per NOC:

- NOCs may have a maximum of three (3) quota places per event in case represented by minimum 3 athletes within the highest 30 places of the World Triathlon Individual Olympic Qualification Ranking as of 14 June 2021. Other NOCs may have a maximum of two (2) quota places per event.

##### 3. Type of Allocation of Quota Places:

The quota place is allocated to the NOC.

#### C. ATHLETE ELIGIBILITY

All athletes must comply with the provisions of the Olympic Charter currently in force, including but not limited to, Rule 41 (Nationality of Competitors) and Rule 43 (World Anti-Doping Code and the Olympic Movement Code on the Prevention of Manipulation of Competitions).

Only those athletes who comply with the Olympic Charter may participate in the Olympic Games Tokyo 2020.



## QUALIFICATION SYSTEM – GAMES OF THE XXXII OLYMPIAD – TOKYO 2020

### Additional IF Eligibility Criteria:

To be eligible to participate in the Olympic Games Tokyo 2020, all athletes must meet one of the following requirements by 14 June 2021:

- Being among the top 140 in the World Triathlon Individual Olympic Qualification Ranking for qualification places of World Triathlon Mixed Relay Olympic Qualification Ranking, World Triathlon Mixed Relay Qualification Event, World Triathlon Individual Olympic Qualification Ranking and Host Country;
- Being among the top 180 in the World Triathlon Ranking for the qualification places of World Triathlon Ranking and Tripartite Commission Invitation.

The criteria/points system of the World Triathlon Mixed Relay Olympic Qualification Ranking, World Triathlon Individual Olympic Qualification Ranking and the World Triathlon Ranking as well as the qualification criteria for all the events counting towards any of the lists/rankings can be found on the official website of World Triathlon, <http://www.triathlon.org/about/documents>

## D. QUALIFICATION PATHWAY

### QUALIFICATION PLACES

The qualification events are listed in hierarchical order of qualification.

All athletes are eligible for both individual and mixed relay events.

14	<p><b>World Triathlon Mixed Relay Olympic Qualification Ranking as of 1 May 2021</b></p> <p>The seven (7) highest ranked NOCs on the World Triathlon Mixed Relay Olympic Qualification Ranking as of 1 May 2021 will be allocated two (2) quota places per gender for their NOC at the end of the World Triathlon Olympic Qualification Period.</p> <p>If there are less than two (2) eligible athletes in any of the genders, the quota places will be allocated to the next highest ranked NOC of the World Triathlon Mixed Relay Olympic Qualification Ranking with two (2) eligible athletes per gender.</p>
6	<p><b>World Triathlon Mixed Relay Olympic Qualification Event</b></p> <p>The World Triathlon Mixed Relay Olympic Qualification Event will take place on 21 May 2021 in Lisbon, Portugal.</p> <p>Only NOCs that have not qualified in the highest seven (7) positions of the World Triathlon Mixed Relay Olympic Qualification Ranking are eligible to participate in the World Triathlon Mixed Relay Olympic Qualification Event.</p> <p>The three (3) highest placed NOCs from the World Triathlon Mixed Relay Olympic Qualification Event not yet qualified via the World Triathlon Mixed Relay Olympic Qualification Ranking will be allocated two (2) quota places per gender for their NOC at the end of the World Triathlon Olympic Qualification Period.</p>

	<p>If there are less than two (2) eligible athletes in any of the genders in the NOCs that finish in the three (3) highest placed, the quota places will be allocated to the next highest placed NOC of the World Triathlon Mixed Relay Olympic Qualification Event with two (2) eligible athletes per gender.</p> <p>If quota places will not be allocated via the World Triathlon Mixed Relay Olympic Qualification Event, those will be allocated to the NOC of the next highest ranked athlete according to the World Triathlon Individual Olympic Qualification Ranking.</p>

26	<p><b>World Triathlon Individual Olympic Qualification Ranking as of 14 June 2021</b></p> <p>The 26 highest ranked athletes, on the World Triathlon Individual Olympic Qualification Ranking as of 14 June 2021 will be allocated one (1) quota place for their NOC, respecting the maximum quota allocation per NOC per event.</p> <p>The events counting for the World Triathlon Individual Olympic Qualification Ranking will take place between 11 May 2018 and 10 March 2020; and between 1 May 2021 and 14 June 2021.</p> <p>NOCs that have already qualified quota places via the World Triathlon Mixed Relay Olympic Qualification Ranking, the World Triathlon Mixed Relay Olympic Qualification Event or Host Nation will not be considered with their two (2) highest ranked athletes for this list.</p>
5	<p><b>World Triathlon Ranking as of 14 June 2021</b></p> <p>In order to ensure continental representation, the highest ranked NOC not yet qualified will receive one (1) quota place for their NOC.</p> <p>The allocation is done in the following priority order:</p> <ol style="list-style-type: none"><li>1. Africa</li><li>2. Americas</li><li>3. Asia</li><li>4. Europe</li><li>5. Oceania</li></ol> <p>If there is no eligible NOC according to the World Triathlon Ranking for a particular continent, the quota place will be allocated to the NOC of the next highest ranked athlete according to the World Triathlon Individual Olympic Qualification Ranking, irrespective of the continent and NOCs may already obtained one (1) quota place. Should the place be allocated to an NOC that had not previously obtained any quota place, this NOC is no longer considered for the allocation of a continental representation place via the World Triathlon Ranking as of 14 June 2021.</p> <p>The events counting for the World Triathlon Ranking will be according to the criteria outlined on the official website of World Triathlon, <a href="http://www.triathlon.org/about/documents">http://www.triathlon.org/about/documents</a>.</p>



## QUALIFICATION SYSTEM – GAMES OF THE XXXII OLYMPIAD – TOKYO 2020

### HOST COUNTRY PLACES

The Host Country is guaranteed two (2) quota places per gender provided that they comply with the eligibility criteria outlined in **Section C.** above.

If there are less than two (2) eligible athletes in any of the genders, those unused quota places will be added through the World Triathlon Individual Olympic Qualification Ranking.

### TRIPARTITE COMMISSION INVITATION PLACES

Two (2) quota places per gender will be allocated according to the Tripartite Commission Invitation and they are made available to eligible NOCs at the Olympic Games Tokyo 2020.

On 1 October 2019, the International Olympic Committee will invite all eligible NOCs to submit their requests for Tripartite Commission Invitation Places. The deadline for NOCs to submit their requests is 17 January 2020. The Tripartite Commission will confirm, in writing, the allocation of invitation places to the relevant NOCs after the end of the qualification period for the concerned sport.

If the Tripartite Commission is not able to allocate a Tripartite Commission Invitation Place, it will be reallocated to the next highest ranked NOC, according to the World Triathlon Individual Olympic Qualification Ranking, respecting the maximum number of athletes per NOC specified above.

### E. CONFIRMATION PROCESS FOR QUOTA PLACES

Following the last event of the qualification period, World Triathlon will publish the results on its website (<http://www.triathlon.org/results>).

World Triathlon will inform the respective NOCs of their allocated quota places within seven (7) days of the end of the qualification period.

The NOCs will then have two (2) weeks to confirm if they wish to use these quota places, as detailed in paragraph **G. Qualification Timeline.**

### F. REALLOCATION OF UNUSED QUOTA PLACES

#### REALLOCATION OF UNUSED QUALIFICATION PLACES

If an allocated quota place is not confirmed by the NOC by the confirmation of quota place deadline or is declined by the NOC, the quota place will be reallocated as follows:

- Unused quota place from the World Triathlon Mixed Relay Olympic Qualification Ranking, World Triathlon Mixed Relay Olympic Qualification Event and World Triathlon Individual Olympic Qualification Ranking will be reallocated to the next highest ranked NOC, according to World Triathlon Individual

Olympic Qualification Ranking, respecting the maximum number of athletes per NOC specified in paragraph **B. Athletes Quota**.

- Unused quota place from the World Triathlon Ranking will be reallocated to the NOC of the next highest ranked athlete from the respective continent according to the World Triathlon Ranking without a qualification place. If there is no eligible NOC from the respective continent, the quota place will be allocated to the NOC of the next highest ranked athlete according to the World Triathlon Individual Olympic Qualification Ranking, regardless of the continent, respecting the maximum number of athletes per NOC specified in paragraph **B. Athletes Quota**.

### REALLOCATION OF UNUSED HOST COUNTRY PLACES

Any unused Host Country Place will be reallocated to the next highest ranked NOC, according to the World Triathlon Individual Olympic Qualification Ranking, respecting the maximum number of athletes per NOC specified in paragraph **B. Athletes Quota**.

### REALLOCATION OF UNUSED TRIPARTITE COMMISSION INVITATION PLACES

Unused Tripartite Commission Invitation Place(s) will be reallocated to the next highest ranked NOC, according to the World Triathlon Individual Olympic Qualification Ranking, respecting the maximum number of athletes per NOC specified in paragraph **B. Athletes Quota**.
